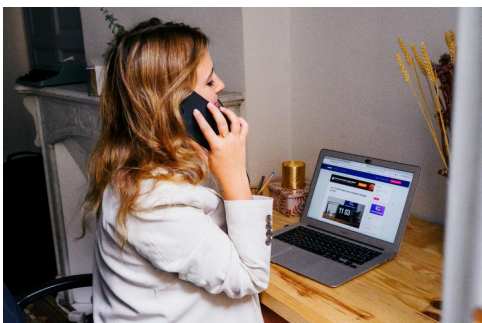

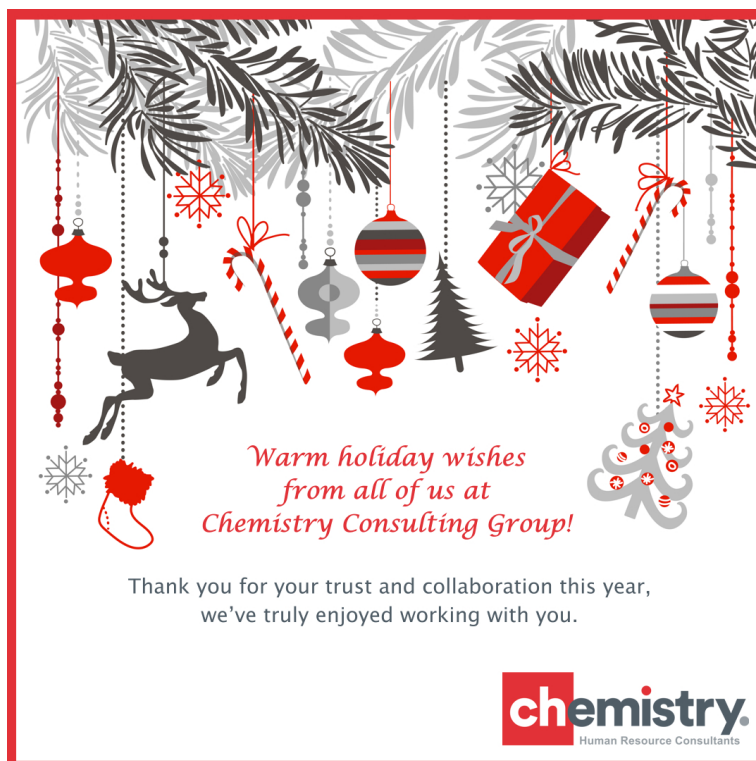
The overall unemployment rate declined to 6.5% in November.
